MEMBERSHIP AGREEMENT

I agree to the following terms of membership at Blue Trail Range Corporation, 316 North Branford Road, Wallingford, CT 06429 (called "Range" in this Membership Agreement.)

I have the right to use all Range facilities that are open to the general public during normal business hours. I understand that the Range may suspend or terminate my membership at any time, in its sole and absolute discretion, for non-payment of membership fees or for violation of any of the Range's rules. I understand that if my membership is suspended or terminated, I will not receive a refund of unused membership fees.

Annual memberships are for a term of one year from the date of registration and payment of annual fee. Annual memberships may be renewed by payment of the then current annual fee. Renewed memberships will continue to be subject to the terms of this Agreement, including the requirement to abide by all Range rules

Monthly memberships will continue indefinitely unless cancelled. Monthly memberships must be paid, in advance, by automatic debit from my bank account or charge to my credit card. If there is any change to the monthly membership fee, I agree to execute a new debit/credit card authorization for the updated amount. I may cancel my monthly membership by giving thirty (30) days prior written notice, either by certified mail addressed to Blue Trail Range Corporation, 316 North Branford Road, Wallingford, CT 06429, hand-delivery to Range management or e-mail to kyle@bluetrairange.com. I understand that I will not receive a refund of unused membership fees.

I understand that I am obligated to pay my membership fees regardless of whether or not I use the Range. I agree to notify the Range of any change in my contact information (including address, telephone number or email address) or change in bank/credit card information promptly.

I understand that use of Range facilities is entirely at my own risk. I agree to indemnify and hold the Range harmless against any and all claims of loss or damage without limitation.

I have read, understand and agree to abide by all Range rules. I agree to abide by all verbal instruction and direction given by Range safety officers or Range management.

Pursuant to the laws of the State of Connecticut, the United States of America, and any other applicable law or regulation, I certify that I am legally authorized to possess, own and handle a firearm. I certify that I have never been the subject of a criminal or civil proceeding that prevents me from currently possessing, owning or handling a firearm. I agree that I will immediately inform Range management if for any reason I am later legally prohibited from possessing, owning or handling a firearm. If this happens, I will receive a refund of any unused membership fees.

I certify that all information I provided in my membership registration and all certifications that I have provided in this Membership Agreement are true and correct to the best of my knowledge.

I certify that I have read this Membership Agreement, and that by signing below, I acknowledge that I understand and agree to be bound by all of its terms and conditions. I further acknowledge that a fully executed copy of this Membership Agreement has been provided to me.

Range Rules (Page 1 of 2):

1. Always keep the gun pointed in a safe direction.
2. Always keep your finger off the trigger until ready to shoot.
3. Be sure your gun is safe to operate.
4. Be thoroughly familiar with how your gun operates.
5. Use only the correct ammunition for your gun.
6. All guns must be carried unloaded with actions opened when exposed.
7. Cease fires for each range shall be called by range officer. When the buzzer sounds, all firing shall immediately cease. Unload, open action, remove magazine and ground or bench all firearms during a cease fire.
8. NO handling of firearms shall be permitted during a cease fire.
9. Firing shall commence only after the appropriate call by the range officer.
10. All shots will be fired at assigned target only.
11. Eye and ear protection are required.
12. Know and obey all range commands.
13. Know where others are at all times.
14. Shoot only at authorized targets.
15. Ground level targets are prohibited.
16. Use of range is prohibited when there is not a range officer on duty.
17. Relays will be run to allow for changing targets. During target change, guns will be grounded, pointed downrange, actions open, completely unloaded.
18. No one is permitted ahead of the firing line except during target changes.
19. Do NOT handle any firearm, and stand away from firearms during a cease fire.
20. NO rapid fire with centerfire rifles or handguns.
21. No alcoholic beverages shall be allowed on the premises.
22. No profane language is allowed on the range.
23. The range officer or range manager shall have the right to close the range to firing at any time he/she believes that conditions are unsafe.
24. Always keep the muzzle pointed at the backstop or bullet trap. Never allow the muzzle to point in any direction that would allow a bullet to leave the range in the event of an accidental discharge.

Range Rules (Page 2 of 2):

The following are prohibited at Blue Trail Range:

- Fully automatic rifles
- 0.50 Caliber BMG rifles
- Exploding targets
- Fixed position steel targets
- Tracers and incendiaries ammunition
- No targets other than paper targets and other specifically authorized targets are allowed
